CANADA CUSTOMS EXPORT DECLARATIONS

This is a reminder to all customers that The Canada Border Services Agency (CBSA), now responsible for the enforcement of the Customs Act. , (previously the responsibility of the Canada Customs and Revenue Agency - CCRA) require all Export Declarations be submitted "prior to sailing".

Effective February 2, 2004 exporters not conforming to these regulations could be subject to fines under the Administrative Monetary Penalty System (AMPS). This can be done one of three ways:

- Authorized Summary Reporting, if this has been granted by CBSA/CCRA
- Canadian Automated Export Declaration (CAED), electronically sent to Stats Canada
- Manual B13A Form is prepared and *TIME STAMPED* at your local Customs office

If you file electronically, yourself then we require your CAED (Canada Automated Export Declaration) number together with your Bill of Lading instructions by 4.00pm on the last receiving date (via fax or e-mail). *Your CAED number must include Authorization Number / Form ID Number / License Number.*
Example: 12X543SC12342003-10-00546

For those that manually type their B13A's you are required to have these time stamped at your local customs office. Once this is done, a legible copy must be sent to Cargo Int'l Prior to 4:00 pm of the last receiving date. If you would like Cargo Int'l to arrange for your copy to be stamped, we must have your completed form by 2:00 p.m. of last receiving date in order to meet our Customs courier service. Please note that effective February 1, 2004 there will be a Stamping Fee of US \$25.00 / export booking that will be added to your freight invoice.

To avoid the extra work and costs associated with the Manual B13A Form, we strongly recommend you contact Stats Canada regarding the CBSA/CCRA software: Tel: 1-800 257 2434 or visit www.statcan.ca/english/exports to obtain a copy.

As all should be aware, new CBSA/CCRA export regulations will soon be in place requiring all marine export declarations be submitted "48 hours prior to receiving", or cargo cannot be loaded. The CAED filing number or the TIME STAMP on the B13A form is your Proof of Report and must be reported to the s/s line to ensure loading.
